Finances:

Mrs. Dinger questioned the PSE&G for the August and September amount being higher than the rest of the summer.

Mr. Grimm said that PSE&G is always a month behind in their bill.

It was questioned about who ALL COLORS LLC. company, and what the payment was for. Mr. Grimm said that they were the clothing gift for the Synchro and Swim team for end of the season gifts.

Mr. Grimm said that there was a freezer that needed to be fixed in the snack bar this summer. He said that all the bills from the snack bar should be all paid for except maybe one Zupko's bill which will be paid for soon.

Mr. Grimm said that the ice maker in the snack bar will need to be replaced this upcoming spring.

Old Business:

1. Membership Fee increases for 2024.

Residents of Middlesex Borough Memberships

Family membership increased from \$295.00 to \$310.00. Single membership increased from \$205.00 to \$215.00. Couple or Parent and One Child increased from \$250.00 to \$265.00. Senior membership increased from \$55.00 to \$60.00.

Non-Resident Memberships

Non-Resident Family membership increased from \$415.00 to \$430.00. Non-Resident Single membership increased from \$265.00 to \$275.00.



Non-Residents Couple or Parent and one Child increased from \$340.00 to \$355.00. Non-Resident Senior membership increased from \$85.00 to \$90.00.

Guest Passes increased from \$10.00 to \$15.00.

Birthday Parties deposit increased from \$35.00 to \$50.00.

Aqua Zumba increased from \$45.00 to \$60.00 for members of the pool. Aqua Zumba increased from \$80.00 to \$100.00 for non-members of the pool.

Swim Team registration fee increased from \$80.00 to \$ 90.00. Synchronized Swimming registration fee increased from \$80.00 to \$90.00.

Publicity Report for October 18, 2023 Meeting

Our goal should always be to have our members and the community think of the property not just as "the pool." Publicity, like safety, is always a moving target. We should always be looking for new opportunities to publicize the Pool.

<u>New Neighbor Letters</u>: Spreadsheet with towns and addresses was sent to Katie in June and September 2023. Katie audited the addresses given, and out of a total of 201 letters sent, 11 memberships were purchased.

<u>Chronicle Article – Fall Wrap-up</u>: Covered: Member thank you, store membership cards for winter, 2024 pricing, summer jobs.

Logo Contest:

The final winning logo was chosen in February 2023. It's pretty disappointing that it is now October 2023, and no prizes have been awarded to our two contest winners. This is not right.

I've been asking Mark since February 2023, after the winning logo was chosen, when we're going to issue the prizes and never got an answer from him.

We established a set of rules at the April 2022 meeting. In an email dated Monday, May 23, 2022, I sent the entry form and the content of contest rules to the commission for their input. There were one or two minor corrections and a response on Wednesday, June 25th, from Joe Rudawski: "No comments or changes from me. Documents contain what was discussed at the last meeting." No further comments were made by the commission.

I have presented the commission with printouts of the contest rules where it states: "The designer of the winning logo will be able to choose one item from the Pool Apparel Store bearing their winning logo...."

In summary: We established a set of contest rules, agreed on them, and posted them as a public contest on the Borough website. Now you want to go back on what we offered.

We are not telling them what they are getting; we are honoring the original rules that award them to receive an item of their choice from the apparel store.




If you entered a contest for a monetary prize, say \$100, and all of a sudden were told "we're only giving you \$10." How would you feel?
